I also suggest that you share this information with your Athletes' Commission. I remind you that one of the responsibilities under the Code is to require National Federations to conduct education. The auditor must fill out a short registration form by clicking the link. He has to choose CMAS - Confédération Mondiale des Activités Subaquatiques, in the field **"your affiliated organisation"**.

Additionally, ITA informed that in the meantime, researchers from the University of Birmingham (UK), funded by WADA and in collaboration with the ITA, are conducting a study to understand athletes' experiences of anti-doping education better. This involves a 10-minute online survey an athlete completes before participating in the IF series. This is optional and requires the athlete to opt in during registration. If the athlete consents, the research team will follow up with the athlete in 12 months to conduct a follow-up survey.
